What type of information we have

We currently collect and process the following information:

How we get the information and why we have it

What we do with the information we have

We may share this information within the organisation for membership, administration, educational and workshop purposes.

We share our Practitioners' preferred public contact information via our website as part of our "find a Practitioner or Teacher" page. This is both to support our Practitioners and Teachers and enable the enquiring public to find, or verify that they have found, a suitably qualified Metamorphic Technique® Practitioner or Teacher.

How we store your information

Your data protection rights
